When you file your income tax return please include both pages of this form.

Notes: Most individuals can use this form to compute the interest penalty due. However, some individuals may be able to compute a lower interest penalty if they complete the long method version of form IT/SD 2210.

- You made married filing jointly estimated income tax payments, but you don't file your income tax return as married filing jointly.
You earned more than 75% of your income in the last nine months of the year.
You made estimated tax payments after a required due date but before the next required due date.
Your combined state income tax withholding and school district income tax withholding is either equal to or greater than (i) 100% of your year 2007 combined state and school district income tax or (ii) 90% of your year 2008 combined state and school district income tax or (iii) your year 2008 combined state and school district income tax reduced by \$500.
At least two-thirds of your gross income was from farming or fishing.
