# School District Year 2008 Estimated Income Tax Payments Worksheet #1

Use this worksheet to determine your liability for school district income tax due to any school district other than the alternative school districts set forth in the listing following "Worksheet #2" on the next page.

If you filed a school district income tax return for last year and if you will be making estimates based on the "last year's tax" method, skip lines 1 through 8 and enter on line 9, below, 100% of the tax shown on line 8 of the 2007 Ohio form SD 100.

**Note 1:** If you move during the year and you will be residing in more than one school district that imposes the school district income tax, then you will need to complete a separate worksheet for each school district.

**Note 2:** You can avoid paying school district estimate income tax if the sum of (i) your 2008 Ohio income tax withholding and (ii) your 2008 school district income tax withholding and (iii) \$500 is equal to or greater than the sum of (i) your 2008 Ohio income tax and (ii) your 2008 school district income tax.

**Credit Card Payments**

You can use your Discover/Novus, VISA, Master Card or American Express card to pay your estimated Ohio income taxes. Make your credit card payments either by calling **1-800-2PAY-TAX** or by visiting **tax.ohio.gov** and clicking on the "Ohio I-File" link. There is a convenience fee for this service. This fee is paid directly to Official Payments Corporation and is based on the amount of your tax payment. Do not file Ohio voucher SD 100ES if you use the credit card method of payment.

**Federal Privacy Act Notice**

Because we require you to provide us with a Social Security number, the *Federal Privacy Act of 1974* requires us to inform you that providing us with your Social Security number is mandatory. Ohio Revised Code sections 5703.05, 5703.057 and 5747.08 authorize us to request this information. We need your Social Security number in order to administer this tax. Your failure to supply any information requested on a tax form prescribed by the tax commissioner may result in (i) the imposition of penalties for failing to file a complete tax return or (ii) the denial of a license, if applicable.
