

The Tax Commissioner, upon consideration of the application filed by the County Treasurer and County Auditor on April 20, 2020, for an extension of time for the payment of real property taxes in the county for the second-half collection of tax year 2019, based upon an unavoidable delay, as provided by Revised Code section 323.17, finds that the extension of time is necessary and hereby extends the date for the payment of the real property taxes and assessments in the County for the second-half collection of tax year 2019 from July 20, 2020, to August 5, 2020, pursuant to Ohio Revised Code section 323.17.

In consideration of the foregoing extension, the Tax Commissioner directs that the extension be publicized in the same manner usually employed to advise real property owners of the time when penalties shall attach for late payment of taxes.
